# Monthly 2024 - 2025 Tuition & Policies

**Registration Fee:** \$25 non refundable registration fee **per dancer.**

**Tuition is due on or before the FIRST of each month.** Tuition not received by the fifteenth of the month will be automatically charged a \$15 late fee. If tuition is still not paid by the fifteenth, we reserve the right to run the card on file. If there is no card on file, students will not be allowed to participate until balance is paid in full. Exceptions or payment arrangements will be considered only if they are arranged BEFORE a due date and are at the discretion of the director.

**The studio does NOT prorate** classes and will not issue refunds or give discounts for any missed time or classes. If a student is absent, arrives late or leaves early, payment must still be made in full. The fee listed above is your monthly tuition fee regardless of how many or how few classes you or your dancer chooses to attend or how many weeks are in each month. If a class cancellation is initiated by the studio, a makeup class will be scheduled and announced. We have released a calendar of pre-determined breaks and will honor this break schedule unless otherwise stated.

**Drop Class Notice:** if you and/or your child intend(s) to withdraw from our program, you must contact the Director and give 30 days notice. **You WILL be financially responsible for any/all fees in the month which you drop.** If you do not pay for this time, your contract will be turned over to collections for the remaining balance due. Greater Heights School of Dance does not issue tuition refunds for months not completed.

**Any fees not paid within 60 days** of bill date will be turned over to collections and your dancer will lose their spot in any/all classes they have been enrolled in. This is a binding financial contract and will be submitted to a third party to collect. Accounts turned over to collections will be subject to any and all fees incurred by collections agencies in an attempt to collect the debt.

**Costuming:** Dancers are required to purchase costumes for every dance routine they choose to participate in. Most classes will require two costumes per year, but each class is always subject to requiring more than two. A costume deposit fee may be due first - any deposits not made will result in a costume not being ordered for your dancer. Final costume payments are due before your dancer can take home their costume. All costume fees are completely non-refundable. Dancers without costumes will be unable to participate in performances or pictures. Any alterations are the responsibility of the parent. If you choose to drop a class after costumes have already been ordered, you are still financially responsible for the total costume fee - no costume refunds can be made. Please budget for around \$75 / costume, with the understanding that it could be a little less or a little more depending on costume availability.
